THE PROCESSION

THE FACULTY MARSHAL

The procession is led by the Faculty Marshal, a senior member of the full-time faculty.

THE DEAN'S GROUP

The Dean's group includes the Dean, the President or President's delegate, the Provost, the Associate Deans, a member of the clergy, the Student Bar Association President, the class valedictorian, the Faculty Marshal, and the commencement speaker.

THE FACULTY & ADMINISTRATION

The ascending faculty ranks include Assistant Professor, Associate Professor, and Professor of Law. Additional faculty ranks include Professor of Academic Success, Professor of Bar Studies, Professor of Clinical Studies, and Professor of Legal Writing. The arrangement of faculty and administrators in the procession, however, does not reflect rank or title.

THE CANDIDATES FOR DEGREES

The students in the procession are candidates for the degree of Juris Doctor.

REGALIA

Since the 14th century, scholars have displayed academic achievement by wearing caps, gowns, and hoods. Gowns for the Juris Doctor display broad velvet panels down the front and three velvet bars on the full, round, open sleeves. The hood, worn over the doctoral gown, gives additional color and meaning to the academic costume. A black shell lined with the colors of the institution conferring the degree, in this case purple and white, the hood is bordered in velvet in the color of the field of study. The velvet trim in purple on both the gown and hood signifies the Juris Doctor degree.

All graduates are hooded during the commencement ceremony, most by members of the faculty. It is tradition at Capital to extend an invitation to any graduate to be hooded by a family member or mentor who also possesses a Juris Doctor degree.

Some graduates wear stoles or cords with their regalia to represent the organizations in which they were involved with while in law school. This year, stoles will be worn by the Black Law Student Association in kente cloth, the Law Review executive board in gold, the Mock Trial and Moot Court in platinum, the OutLaws executive board in lavender & rainbow, Student Bar Association executive board in purple, and the Women's Law Association executive board in white. Wearing cords will be the Admissions Ambassadors in intertwined purple and gold, American Civil Liberties Union in intertwined white and royal blue, the Christian Legal Society in white, the Corporate and Business Law Association in intertwined black and royal blue, the First Generation Law Student Society in double black and silver, the Law Review in gold, the OutLaws in rainbow, the Capital Law Republicans in red, the Sports and Entertainment Law Association in intertwined black and kelly green, the Student Bar Association in purple, the Torts and Injury Law Society in orange, and the Women's Law Association in intertwined lavender and white.

MACE

The University Mace is carried by the Faculty Marshal in the processional and recessional. It was originally derived from a medieval weapon representing the need to protect and nurture the fragile search for knowledge. Over the centuries, it has become a symbol of order and authority. Today, the Mace has a place in many universities' ceremonies, signifying the beginning and end of the event.

COMMENCEMENT SPEAKER

A series of firsts defines the life and career of former Ohio Supreme Court Justice Yvette McGee Brown. A first-generation college graduate, McGee Brown was raised by a single mother on the East side of Columbus. She was the first African-American woman elected to the Franklin County Common Pleas Court in 1992. She resigned from the common pleas court in 2002, to create a nationally recognized organization that redefines how hospitals, law enforcement, and social welfare groups respond to children and families caught in the cycle of abuse. In January 2011, she became the first African-American woman to serve as a justice on the Supreme Court of Ohio. Today, McGee Brown is the Global Partner-in-Charge of Diversity, Inclusion, and Advancement at Jones Day and a partner in the business and tort litigation practice.

McGee Brown is an active community and corporate leader. She has served on the boards of the Dave Thomas Foundation for Adoption, Ohio University, the OSU Wexner Medical Center, the National Council of the OSU Moritz College of Law, M/I Homes Inc., and Fifth Third Bank of Central Ohio. McGee Brown currently serves on the Board of Directors for Encova Mutual Insurance Group, The Jeffrey Company, and KIPP Columbus.

Among her many honors are the Ohio University Medal of Merit, The Ohio State University Distinguished Service Medal, the American Red Cross Humanitarian of the Year, Best Lawyers in America, Savoy Magazine's Most Influential Women in Corporate America, and 2024 Lawdragon Hall of Fame – 500 Leading Litigators in America.

McGee Brown has a bachelor's degree in Journalism/Public Relations from Ohio University and a Juris Doctorate from The Ohio State University Moritz College of Law. She has honorary doctorate degrees from Ohio Dominican University, Urbana University, and Wilberforce University.

McGee Brown is married to Tony Brown, a retired educator. They have three children and two grandchildren.
